INITIATIVE, REFERENDUM AND RECALL EFFORTS:

Before circulating petitions, a political committee must file a Statement of Organization with the appropriate filing office. Signatures obtained on petitions prior to the filing of the Statement of Organization are VOID and shall not be counted in determining legal sufficiency of the petition. A.R.S. §§19-114.B and 19-202.C. The Statement of Organization must be filed regardless of whether the committee intends to accept contributions or make expenditures.

INDIVIDUALS INVOLVED IN POLITICAL ACTIVITIES:

An individual acting alone, is not a political committee under Arizona law and need not file a Statement of Organization. If any additional person or persons join the effort (as defined in A.R.S. §16-901.20), the association or combination of persons becomes a "political committee" and must file a Statement of Organization before accepting contributions, making expenditures, distributing literature or circulating petitions. A.R.S. §16-902.01.A.
